Since 2008, Kay had many notable accomplishments which included: successfully implementing the Entrepreneurial Operating System (EOS) business model to guide, streamline and drive efficiency in the organization's strategic and tactical planning processes; creating a reserve fund to protect the financial health of the organization; and launching the Applied Science for Kids (ASK!) program 11 years ago with the Cleveland Metropolitan School District, which significantly expanded the organization's environmental and science education programming and increased its reach to underserved youth in the region. In 2019, Kay was named a Notable Woman in Nonprofits by Crain's Cleveland Business. Most recently, Kay's visionary leadership lead to the completion of a successful capital campaign from 2017 to 2021, which included a transformative restoration of the Nature Center's trails and habitats. While her presence is missed by all of those who knew and worked with Kay, she ensured a smooth transition of leadership to Peter Bode and the Nature Center & community wish Kay a healthy and happy retirement.

Expanding Reach and Inspiring Students through Summer Adventures



Throughout the year, our dedicated education team worked tirelessly to uphold the highest standards of environmental education through offering the first year of a fully American Camp Association (ACA) accredited camp and reaching new students in our community through expanded financial aid opportunities.

Meeting Accreditation Requirements

In 2022, the Nature Center enhanced our camp training procedures, aligning them with the stringent accreditation requirements set forth by the American Camp Association (ACA). As the only national accrediting body for camps of all types, ACA's standards focus on health, safety, and risk management, serving as benchmarks even for government entities.

Lauren Schmidt, Environmental Educator, meticulously documented and compiled existing records, ensuring that our camp met ACA's rigorous accreditation standards. This effort aimed to provide public evidence of our unwavering commitment to the well-being of both campers and staff.

The hard work paid off, as during the 2022 camp season, our education team successfully implemented the necessary changes. We showcased our compliance with ACA standards to a representative of the ACA, and in October 2022, the Nature Center at Shaker Lakes became an accredited program. Outdoor Adventure Camp 2023 led by new Outdoor Adventure Camp Manager, Hunter Hammil, became the first year we offered a fully ACA accredited camp experience which opened doors for the Nature Center's reach and financial aid offerings.

Enhancing Accessibility

At the core of the Nature Center's mission is the goal of making environmental education accessible to all members of our community. To achieve this, we have developed financial aid and intern programs that have demonstrated remarkable success. These initiatives have not only facilitated greater accessibility but also fostered a path of growth and development for our interns. Many of our interns express desire to return year-after-year, creating a sustainable pipeline from volunteer to intern to educator.

Impactful Financial Aid Programs

One of the most significant achievements in 2022 was the substantial increase in financial aid recipients. An impressive 12.7% of campers received financial aid, totaling \$16,271.38 in aid awarded to the Nature Center and our partners. This support has enabled us to welcome a diverse group of campers, ensuring that the Nature Center's programs are available to all, regardless of their financial circumstances.

Fulfilling Our Mission

The Nature Center at Shaker Lakes takes great pride in meeting its financial goals while extending support to the community. In 2022, we not only achieved our revenue targets but also distributed \$5,217 in financial aid, further underlining our commitment to inclusivity and accessibility.


Looking Forward

Volunteer Engagement Reaches All-Time High

Sara Borse, our dedicated Volunteer Manager, has been an instrumental force in the remarkable growth of our volunteer program at the Nature Center this past year. In FY23, under her leadership, we experienced a phenomenal 120% increase in volunteers, with 820 individuals generously offering their time and expertise compared to the 375 volunteers in FY22 prior to Sara joining our team. This tremendous expansion is not only seen in numbers, but also in the substantial rise in service projects completed. In FY23, we successfully undertook 24 service projects with school and corporate groups, a notable increase from the 9 projects in FY22. Moreover, Sara's outstanding efforts are evident in the significant threefold growth of our trail ambassador volunteers. The impact of her leadership is further evident in the Summer Teen program, where hours of engagement surged from 1,818 hours in FY22 to a remarkable 3,228 hours in FY23. Sara's dedication and skill in attracting and retaining volunteers have been a driving force in our mission to inspire a love of nature in our community.




JENNA LOVEMAN: Youth Volunteer of the Year

Summer Youth Stewards Share Their Passion with NCSL

On a sunny summer afternoon in June, marketing content manager, Alexandria Yurosko sat down with this year's Summer Youth Stewards Kiran Herbert and Jenna Loveman to talk about their experiences working as Summer Youth Stewards.

Hi Kiran & Jenna thanks for sitting down with me to talk! What were you doing in the marsh doing today?

We were replanting a site that we had cleared of invasive shrubs a few days prior. Nick [Mikash] often delivers plants from the boardwalk to us standing below in the marsh. He then directs us to the plant's final destination in the habitat.

Can you tell me a little about your backgrounds?

Sure! This is my second year working as a Summer Youth Steward for NCSL. I went to high school at Hawken and plan to attend Boston College for environmental studies.

Kiran and I have worked together in the past, this is actually my third summer working as a Summer Youth Steward. I went to Shaker Heights for high school and will attend Skidmore College in Saratoga Springs for environmental science

Those career paths seem fitting given your experiences here. How did you get to know the Nature Center or learn about the position?

K: Growing up in this area, I had been coming to the Nature Center for years. Last summer I was searching online for opportunities when I came across the Summer Youth Stewards. I was interested in pursuing a career path in this field so I was excited to try it out. I loved it so much I asked to come back this summer!

J: In high school, I was looking for volunteer opportunities and a teacher suggested the Nature Center. I was a Summer Youth Steward in 2021 enjoyed it enough to spend three summers here. Both of us worked at the Nature Center for our Senior projects. We worked with Nick all day, followed him and his team planting, removing invasive plants, and received special training to use herbicides where necessary.



You both expressed your passion for the Nature Center was what encouraged you to return as Summer Youth Stewards. What do you like about working here?

K: Every day here is different! I appreciate that we were invited to sit in on weekly meetings and learn more about the Nature Center as an organization. It helped to see how the whole business works, beyond the stewardship aspect.

J: I value the team mentality. The departments support each other and staff are positive and friendly. One time, the education department needed a log moved to demonstrate decomposition. It was fun for us to help out with that project for the students! It's also fun being able to identify plants. I am always pointing out honeysuckle or privet to my friends.

I certainly would echo that team mentality among staff, everyone is so welcoming and I have to think you've experienced that with Nick?

K: Nick is really cool and doesn't talk down to you. You can tell he enjoys his job and helping us learn. He's very open with us and works to make it an interesting experience.



J: We feel lucky to work with Nick and our volunteers. Everyone is so welcoming and friendly. Just the other day, I met Bob [volunteer] and he was asking me about schools I've applied to. He ended the conversation by saying you probably should have a hat for your work today! Then he gave me his hat! It made my day and it was such a nice, fun conversation.

Those interactions are so meaningful, I am sure it makes you feel like you have purpose when you come here.

K: This is a feel-good place. After planting something, I love thinking about how that tree or shrub will be enjoyed by wildlife and visitors for years to come. There is also an element of individual and group responsibility. No one is telling you to make these positive changes to the local environment, it just feels great to be a part of this work.

J: I agree. With climate change and eco anxiety being so prevalent, working here makes me feel hopeful. Its fulfilling seeing kids get interested in science and nature through summer camp and watching them learn. I think I can speak for both of us when we say we love that we are doing something so good for the future.

As we walked together to the entrance of the All Peoples' Trail, Jenna remarked that they were wearing the same pants. "The other day we were out on the trails and I looked at Kiran and was like wait are we wearing the same pants? With the orange zippers?" The two laughed as they realized they had indeed bought identical pants. I smiled because I could tell these hot, summery days working together in the marsh were going to be great memories for both of them—and their friendship that had formed would be one more reason to return next summer.




