Opening Doors for Grant Funding

At the Nature Center, we are more than a destination—our goal is to become a true "Third Place" for all in our community. Beyond home (the first place) and work (the second place), a third place is where people gather to recharge and build connections; it's top of mind when searching for meaningful and tangible peace, spirit, and fellowship. We invite everyone to make this natural space their own, where learning, relaxation, and inspiration coexist in an inviting environment. Whether you're exploring the trails, joining in on workshops, or simply warming up inside by our fireplace, we are here as a welcoming third place for all.

In 2023, the Nature Center at Shaker Lakes (NCSL) entered a new chapter, one marked by its first foray into government grant funding. Historically, public funds had not been leveraged, but with President & CEO Peter Bode's vision, opportunities emerged to apply for government grants that align with the expanding vision. The shift has opened doors to a new era of growth and collaboration in the community.

With the full-time dedication of Maria Asher, Director of Grants & Foundation Relations, the Nature Center has been able to explore and secure key funding sources, both private and public. Notably, NCSL received it's first-ever arts grant from the Ohio Arts Council's ArtSTART program, as well as support from the Nord Family Foundation. The ArtSTART grant supports Summer Wednesdays and other seasonal arts programming, allowing deeper community engagement through the intersection of arts and nature.

The expansion into government funding, however, goes beyond arts programming. The receipt of Cuyahoga County's Healthy Urban Tree Canopy (HUTC) grant marks another first for the organization. This grant enables the Nature Center to conduct essential tree inventory, risk assessment, invasive species removal, and to plant 234 native trees along West Park Boulevard. The HUTC grant is an essential part of countywide efforts to promote a healthier, more sustainable tree canopy.

In addition to these grants, the Nature Center was awarded OhioEPA Large Scale Restoration Grant funding through the Ohio 319 Program, part of a national initiative to reduce nonpoint source pollution and protect Ohio's surface water resources. With this funding the organization will restore 1,500 linear feet of stream. This grant is a vital part of NCSL's commitment to restoring local ecosystems and preserving water quality.

Securing government grants not only provides critical funding but also helps the Nature Center tell its story to new audiences and potential funders. These grants have opened doors for future opportunities, expanding the impact on community, environment, and beyond. Improvements made possible through grant funding ensures your third place continues to be protected and offer dynamic experiences. Through both public and private funding, the Nature Center at Shaker Lakes is poised for continued growth and success.





MEET MARIA ASHER DIRECTOR OF GRANTS & FOUNDATION RELATIONS

In an effort to place more focus on fundraising and development initiatives to support the organization's strategic initiatives and mission, the Nature Center recently restructured the development office. One of the key changes was to create this position. Through this newly elevated role and focus, Maria Asher has stepped in and identified key funding sources that will have a positive and lasting effect on the organization.

Optimizing Resources to Inspire Future Environmental Stewards

The Nature Center's education team works diligently to stretch donor dollars and grants to maximize impact. In 2024, we provided 800+ school programs within 180 school days using only four classrooms on site. While we prefer hosting students at the Nature Center, in addition to classroom limitations, transportation can also be a barrier. As a result, the education team built several creative ways to reach students. Multiple modes of delivery help us maximize reach, especially during our busiest seasons. Regardless of the program format, our goals remain the same: to inspire young environmental stewards through science-based educational curriculum and incorporate nature into their daily routine.





Cultivating a Welcoming Third Space for All

In 2024 the Nature Center expanded programming to reach new audiences and welcome visitors to our space. Community outreach is a strong way for the Nature Center to utilize new channels and build partnerships, which invite first-time visitors. Embodying our role as a Third Place means all feel welcome and encouraged to enjoy nature.

Expanding the Community Engagement Manager position and strengthening our Diversity, Equity, Inclusion, and Accessibility (DEIA) Committee, has increased opportunities to reach community members with diverse interests. Summer Wednesdays, Natural Resources and unique program themes were noticeable areas of growth for our programming calendar. The focus was to combine nature themes with interesting formats to create innovative programs.

Especially successful programs included Winter Warmup Whiskey Tasting, Historic Homes Tour, Seed Collection Workshops, Drag in Bloom (pictured below), and Boozy Birding—a casual and welcoming introduction to the world of birding!

DEIA COMMITTEE HIGHLIGHTS

REFLECTIONS

The DEIA committee began FY24 with a goal of looking inward. The committee's goal was to reflect on the history of our community, challenge assumption, and implement strategies throughout various departments.

RETREAT

In October 2023, the staff and board attended a two-day retreat led by Lance Bennett of L.E.B. Partners. Lance led the team through the personal work of self-reflection and incorporating observations into daily strategies.

IN THE COMMUNITY

In June, the committee toured Rid-All, an urban farm, and shared a delicious farm-to-table meal. Despite its proximity, most of the group hadn't been to Rid-All. This highly-anticipated trip was beneficial as the organization looks forward to future partnerships.

ACTING AND PLANNING

Work was focused on integrating DEIA initiatives throughout the organization and its departments. The committee hosted meetings in which staff and board celebrated achievements and developed methods to deepen our impact.





Expanding Natural Resources Capacity through AmeriCorps

This past year was the first time the Nature Center was able to welcome an AmeriCorps service member to our staff. AmeriCorps provides support to organizations dedicated to the improvement of communities through funding and people power. Northern Ohio Watershed Corps (NOWCorps) is an AmeriCorps program funded through ServeOhio and sponsored by Tinker's Creek Watershed Partners, serving northeast Ohio.

NOWCorps places service members with local conservation organizations, helping expand capacity for ecological restoration, educational outreach, volunteer management and more. Service members receive a monthly stipend and upon completion of their year of service, an educational award that can assist with expenses. Members also receive training, networking and experience as they make their way into these career fields. The host organization covers a portion of the program costs and in return receives a full-time service member for one year.

In our first year with NOWCorps, Miranda Luse (pictured right) joined our team. Her work with the Natural Resources team was invaluable in educating, connecting, and inspiring school groups and volunteers. Her vast knowledge of environmental science and past experience with the Nature Center made her an especially ideal fit for the role.

Along with the Natural Resources team, environmental stewards, and volunteers, Miranda supported invasive plant and bug removal, trail maintenance projects, and revamped our incredibly popular seed library program. She created the "What's in Bloom" guide and similar signage for visitors, and implemented other enhanced educational signage in the exhibit space. We are grateful for the talent, creativity, and knowledge Miranda brought to this role!

We are excited to continue the NOWCorps partnership, which expands the capacity of our natural resources team and the scope of our educational programming.











Backyard birding, once considered a niche hobby, has seen a notable rise in popularity across the U.S., especially in regions like Northeast Ohio. This increase is partly due to the pandemic as more people sought ways to engage with nature in their own backyards. Birdwatching offered a peaceful escape and a way to connect with the outdoors without leaving home.

At the Nature Center and surrounding areas, this new level of interest is noteworthy. The Shaker Parklands is home to eight unique habitats including forests, wetlands, and urban green spaces, which serve as a crucial stopover for migratory birds and is home to a variety of species year-round. The boardwalk and Stearns Woodland Trail offer prime viewing locations and experts like Julie West provide guidance that further fuel the interest in birdwatching.

One driving factor behind the growing popularity is accessibility. Birding doesn't require a lot of expensive equipment—many enthusiasts start with a pair of binoculars and a guidebook, on a guided walk, or using an app like Merlin ID. The hobby is also

family-friendly and accessible to people of all ages, making it appealing to a broader demographic. Traditionally associated with older generations, birdwatching has seen an influx of younger birders, drawn by the tranquility of nature and the opportunity to participate in citizen science through apps like eBird. Parents are often seen engaging with their kids in our bird observation area inside the Nature Center.

The Nature Center has increased the visibility around our biding programs through an online calendar to showcase upcoming programs, such as bird banding and guided walks (usually two each month, one of which is accessible). ASL interpreters welcome all abilities to join and learn!

The Nature Center embraces birdwatching because for many, birding can be an opportunity to encourage bird-friendly, mission-based practices such as planting natives and reducing pesticide use, as well as increasing awareness about conservation efforts. It is our commitment to ensure your third place remain a vibrant birding destination and habitat for years to come.

MEET OUR RESIDENT EXPERT JULIE WEST HONORARY BOARD TRUSTEE

How did you become interested in birding?

Growing up, we had bird feeders in our yard, so I knew the common birds from a young age: robins, blue jays, and cardinals. We often spent time in the Metroparks and took annual camping vacations, so I expanded my bird knowledge along the way.

Bird banding has been a part of the Nature Center for over 20 years, can you share how that came to be?

Gary and I started joining the Nature Center bird walks back in the late 1980's. In 1996, after observing bird banding at Point Reyes Bird Observatory field station in California, I signed up for a bird banding training session in Pennsylvania and then started volunteering at the Black Swamp Bird Banding station in Oak Harbor, Ohio. I eventually qualified for a banding sub-permit which enabled me to band on my own. After retirement in 2001, I started bird banding at the Nature Center with a focus on spring and fall migration. This was made possible with Gary's support, Laura Gooch who has helped daily since his passing, and many dedicated volunteers over the years.

Your volunteer time and expertise are immeasurable! Could you tell us a little more about your role in expanding birding programs at the Nature Center?

Gary and I valued the Nature Center since we first discovered it through the Audubon Spring Bird walks. I refer to it as "an oasis in the middle of suburbia." In 2005, Gary and I started "The Big Sit" at the Nature Center, an event that occurs annually on the second weekend in October around the world. Additionally, I introduced Project FeederWatch to the Nature Center community. Around that time, I joined the Board of Trustees and served the maximum number of terms. After Gary's passing, I continued to lead Audubon Spring Bird Walks until a few years ago. More recently, I joined the Natural Resources Committee, the External Affairs Committee and the DEIA Committee.

Have you observed a resurgence of birding at the Nature Center?

During the pandemic, there were more people who joined bird walks. Some became regulars, while others joined occasionally. Many came as beginners and once they gained some knowledge, started to branch out on their own. I see this pattern continuing today. Increased banding station visitors often stop by to watch and learn more.



WE ASKED JULIE WEST:

Do you have a Spark Bird?

What really captured my attention was when my partner, Gary, took a Birding 101 class and introduced me to warblers, in 1988. They were so colorful and included different species. We were hooked and started going on guided bird walks, many at the Nature Center, and planned our vacations around birding.





WHAT IS A SPARK BIRD?

In birding, a "spark bird" is the bird that first ignites a person's passion for birdwatching. It's typically a species encountered in an unexpected or meaningful way that captivates someone, drawing them into the world of birding. This concept was recently featured in an episode of This American Life, where expert birder Noah Strycker describes howa turkey vulture became his spark bird. Watching the vultures over several days, Strycker was mesmerized by their behavior, drawing him into a deeper fascination with birds. He explains that a spark bird is one that "grabs you in a way that you haven't been grabbed before" and awakens a new under-standing or appreciation of birds and nature. Birders often discuss their spark birds as pivotal moments in their birdwatching journeys.

Important Bird Area

An Important Bird Area (IBA) is a designation by the Audubon Society (and BirdLife International globally) for regions that are essential for the conservation of bird populations. These areas are identified based on scientific criteria that consider the presence of significant populations of endangered, threatened, or endemic bird species, as well as key habitats that are crucial for breeding, migration, or wintering. The Nature Center at Shaker Lakes is considered an IBA.




